Giving away ad space does not help this issue. Considering what is best for our society, I will vote no for Schickworks, and though I can't vote on the Open Book matter because of possible conflict of interest, my vote would be the same.

Stacey provided financial comparisons of programs and ad revenue as well as articles providing the benefits/cautions of in-kind donations.

Ad revenue just for ads by themselves was \$5805.00

Total cost of programs for this year was \$5111.84

For an income of \$693.16 for just ads sold by themselves. If needed, Stacey can factor in the Production and Season Sponsors to know the exact income.

Personally I see in-kind donations as a way for our community to see we support and appreciate those who give to us so generously. I feel it is a reciprocal support system that benefits both sides and continues a community focus in our non-profit society.

Jeff - I agree there are positive benefits to in-kind donations, I believe there can be negative outcomes in the future. Our group used to do in-kind donations and then stopped. When they stopped, they made it a policy to not do in-kind at all for the foreseeable future. While I do not know the situation that prompted the 180° turn on in-kind donations, it is enough that I can't ignore the uneasy feeling I get about it. I hope I'm wrong, but that is also why I'm saying no. I know the board will proceed with this action, I just urge us to proceed cautiously.
